"Exhibitor means a sole proprietorship, partnership or limited company

Eligibility for the Conditions of Participation

The Organizers reserve the right to decline any application without

 All Exhibitors must be legally registered companies either in Hong Kong or in their country of origin. The Organizers may require Exhibitors to produce a copy of their business registration certificate, certificate of incorporation or other company registration documents at any time. The Space is licensed strictly to the Exhibitor for trade promotion purpose only for the duration of the Exhibition.
